Eligibility for SFMNP Food Benefits:

- **Age** — Must be 60 years of age or older on the day of application , AND
- **Income** — Applicants' gross household income must not exceed these limits:
 - \$2,096 monthly ... for a household of ... 1
 - \$2,823 monthly ... for a household of ... 2
 - \$3,552 monthly ... for a household of ... 3
 - \$4,279 monthly ... for a household of ... 4
 - \$5,006 monthly ... for a household of ... 5
 - \$4,835 monthly ... for a household of ... 6

Eligibility Requirements:

1. **Age** - person must be 60 years of age or older the day of application, **AND**
2. **Income level** - recipients' **gross monthly** household income (income before taxes) must not exceed the following limits: \$2,096.00 for a household of 1; \$2,823.00 for a household of 2; \$3,552.00 for a household of 3; \$4,279.00 for a household of 4 (larger household amounts are available online agi.alabama.gov/farmersmarket/)

(Household: a group of related or non-related individuals living together as one economic unit. These amounts are at 185% of 2022-2023 Federal Poverty Guidelines.)
